## CASH LOTTERY

### 2022 Christmas Jingle Cash Lottery Rules Governing Operation of Raffle

1. Age limit for ticket purchasers is 18 years or older and the name of a person under the age of 18 may not be written on the ticket due to requirements of the Public Trustee Act.
2. All sets of multiple tickets must contain the same information.
3. Tickets will not be sold outside of the province of Alberta.
4. The number of tickets printed in this lottery is 73000 structured as: 500 for \$10.00 each, 5000 at 5 for \$20.00, 12500 at 10 for \$30.00 and 55000 at 20 for \$50.00. Total ticket value is \$200,000.00.
5. Tickets may be purchased by VISA and MasterCard. Debit payments will also be accepted at in person sales locations.
6. Ticket control and distribution for Christmas Jingle Cash Lottery will be under the management of Stride Management Corp. 3950 12th Street N.E. Calgary, AB T2E 8H9.
7. All draw(s) will be managed by the firm of Stride Management Corp. 3950 12th Street N.E. Calgary AB T2E 8H9. The draw details are as follows:
